The National Institute for Interdisciplinary Science & Technology (NIIST) Trivandrum, a constituent laboratory under the Council of Scientific and Industrial Research (CSIR), Ministry of Science and Technology, is a premier R&D laboratory carrying out research in the area of Biotechnology and Biofuels.

Expression of Interest is invited from Manufacturers, Indian agents of manufacturers for the supply and installation for Fully Automated Capillary DNA Sequencer.

It is proposed to have technical presentations from all prospective suppliers to have a better understanding of the different models available in the market technical know how of the recent advances in the field of Fully Automated Capillary DNA Sequencer. **The proposed presentations is fixed for 27.10.2011 at 2.00 pm in the Board Room.** The dates cannot be changed under any circumstances. **Please depute a person with sound credentials, technical know how and senior enough for the Presentations & Clarifications which would have to be given to the Technical & Purchase Committee and senior Scientists of this Institute.**

The suppliers expressing interest for the supply of the above should come with the following documents for presentations.

1. Technical Catalogues for models proposed.
2. A copy of the escalation chart of your company should be submitted.
3. List of End users with their telephone, fax, email and model numbers supplied should be submitted. **You must ensure that the End user should pertain to the models being proposed.**
4. A certificate regarding the number of factory trained engineers for the proposed models need to be submitted.
5. **Firms must indicate the response time in case of breakdown of the equipment and have a firm plan in place for the service of the equipment which should be elucidated during the presentation.**
6. Firms should indicate their willingness to have a Resident Engineer stationed at Trivandrum who should also be factory trained for the purpose of the servicing the equipment.

### **Prequalification Criteria:**

The companies interested in the above venture should meet the following pre-qualification criteria:

1. The company should be a manufacturer or supplier of DNA sequencing equipment with at least 5 years experience in dealing such equipment.
2. The companies should have qualified technicians and application specialist in India for equipment installation, demonstration, trouble shooting in case of any problems and for servicing.

### **Technical, manufacturing and managerial strengths:**

- a) Company's background and history, its range of products, manufacturing facilities if any, previous experience and programs particularly if any of these are related DNA sequence analysis.
- b) Types and kinds of capillary sequencer equipment which the company deals/manufactures with technical details
- c) Company's strength in application support and product services
- d) Company's financial strength duly supported by financial statements for the last five years.
- e) Accreditation to any quality standards.
- f) Company's suggested plan for financial, execution, marketing and operational support for the project.
- g) Other relevant aspects.

Only the shortlisted companies or joint ventures will be invited to participate in the limited tender based on the institute's assessment of the EOI document submitted by the company and the institute's decision in this regard will be treated as final and binding.
