Notice Inviting Tender for the empanelment of Hotels for accommodation of NIIST Guests

CSIR-NIIST, Thiruvananthapuram, a premier research laboratory under the Council of Scientific Industrial Research (CSIR) is interested in empanelling Hotels under 3-star, 4-star and 5-star category for a period of one year for accommodating guests who are invited to attend various events during its Golden Jubilee Year during October 2024 to October 2025. Tenders are invited from interested bidders under two bid system, Part I Technical Bid & Part II Financial Bid.

Tenderers are advised to download the tender documents from CSIR-NIIST website https://www.niist.res.in. The bids are to submitted in **two separate sealed envelopes**, one containing Technical Bid and the other containing Financial Bid. The envelopes are to be superscribed as "Tender for empanelment of Hotels for Golden Jubilee Accommodation- **Technical Bid**" and "Tender for empanelment of Hotels for Golden Jubilee Accommodation - **Financial Bid**".

Bidders who do not submit the financial bid separately or quote price along with technical bid document will be disqualified.

The bids are to be deposited at the office of the Administrative Officer or to be sent to the address given below so as to reach on or before **23**rd **September 2024, 10:30 a.m.** Technical Bid will be opened on the same day at 11:00 a.m.

Terms and Conditions

1. Scope of Work

CSIR-NIIST, a premier research laboratory under the Council of Scientific Industrial Research (CSIR), plans to celebrate its Golden Jubilee for 1 Year from October-2024 to October-2025. During this period, CSIR-NIIST intends to host numerous scientific meetings, seminars, and conferences necessitating the accommodation for all distinguished guests and participants including students.

The goal of this activity is to empanel a group of hotels in Thiruvananthapuram under 3-Star, 4-Star, and 5-Star category in order to provide accommodation for the guests attending various events during the Golden Jubilee year of CSIR-NIIST.

2. Eligibility Criteria for empanelment of Hotel:

- i. **Room size**: The size of each room type may be indicated in square feet. The minimum acceptable room size is 200 square feet (approximately 18.5 square meters) for standard rooms.
- ii. **Minimum amenities**: In-room Wi-Fi Air conditioning 24-hour front desk service Room service On-site restaurant Business centre or conference facilities.
- iii. **Guest ratings**: The minimum guest ratings as evidenced from major booking platforms (e.g., Booking.com, TripAdvisor) should be not less than 4 star.
- iv. **Proximity to venue**: The hotel should be located in Thiruvananthapuram city, within 10 km from CSIR-NIIST.

The eligibility criteria should be adequately supported with all relevant documentary evidences.

3. Other Important Information

- i. CSIR-NIIST reserves the right to reject any offer without assigning any reason whatsoever.
- ii. CSIR-NIIST reserves the right to cancel the tender at any stage without assigning any reason. Also, CSIR-NIIST reserve the right to change the condition at any later stage.
- iii. The proposals should be complete in all respect. Conditional / incomplete proposals are liable to be rejected
- iv. Empanelment with this Institute does not ensure business of any quantum, whatsoever.
- v. Any deviation from the Terms & Conditions mentioned above will imply disqualification for the firm.
- **4. Empanelment of Hotels:** The empanelment will be for a period of one year from the award of contract.

- **5. Terms of Payment**: There are two modes of payment- payment by the CSIR-NIIST, Thiruvananthapuram on credit basis or venue payment by the guest. The quoted rates shall apply for both modes of payment. No advance payment will be considered.
- **6. Termination:** The contract may be terminated by either party by giving one month's notice period.
- 7. Force Majeure: Neither party will be liable in respect of failure to fulfil its obligations if the said failure is entirely due to Acts of God, Governmental restrictions or instructions, natural calamities or catastrophe, epidemics or disturbances in the country. The party affected by an event of Force Majeure will immediately notify the other party of such an event and will also notify the unaffected party on cessation of disability resulting from such Force Majeure act
- **8.** Jurisdiction: The contract shall be governed by laws of India and all Government rules on this matter issued from time to time and in force for the time being are applicable to this contract tender.
