1. Invitation for expression of Interest

National Institute for Interdisciplinary Science and Technology (NIIST), invites sealed Expression of Interest (EoI) from Recognized Qualified Person (RQP) in Kerala to whom, certificate were issued under rule 54 of KMMC Rules 2015 for preparation of mine plan for river sand mining in the state of Kerala. The list displayed on the website of Department of Mining and Geology (DMG), Government of Kerala is referred while sending the EOI request.

This EoI document contains the details of qualification, criteria, submission requirement, brief objective and scope of work and evaluation criteria.

2. Background

National Institute for Interdisciplinary Science and Technology (NIIST) is a constituent laboratory of Council of Scientific and Industrial Research, Department of Science and Technology, Ministry of Science and Technology, Government of India. CSIR-NIIST is working in the areas of environmental technology, microbial processes and technology, materials science, agro-processing and chemical sciences. NIIST is a NABET accredited (Category-A) EIA consultant in the areas of mining of minerals and ports & harbors. CSIR-NIIST has prepared the District Survey Report for Malappuram, Palakkad, Thrissur, Kasaragod, Kannur, Kozhikode, Kottayam, Ernakulum, Pathanamthitta, Idukki and Kollam. The potential sand mining sites are identified in each district along various rivers. The DSR is prepared in accordance with the

relevant guidelines provided in the Sustainable Sand Mining Management Guidelines (SSMMG-2016) along with Enforcement and Monitoring Guidelines for Sand Mining (EMGSM-2020). The mine plan has to be prepared for commencing mining operations along with other necessary documents for Environmental Clearance (EC) and this EoI is specifically looking for Recognized Qualified Persons (RQP) who are registered with the Department of Mining and Geology, Government of Kerala under Rule 54 of KMMC Rules 2015.

3. Aim and objective

The objective of the work is to prepare a mine plan for river sand mining in accordance with Enforcement and Monitoring Guidelines for Sand Mining (EMGSM-2020) and other guidelines as given in this EoI. The mine plan will be prepared for various potential sand mining sites of areas ranging between 0-3 Ha, 3-5 Ha, 5-25 Ha and more than 25 Ha.

4. Eol processing fees

There are no processing fees for submitting this Eol.

5. Venue and deadline for submission of proposal

The last date for submission of the proposal is 26-02-2024 via mail and through sealed cover via post is 27-02-2024. Proposal, in its complete form in all aspects as specified in Eol, must be submitted to CSIR-NIIST, Thiruvananthapuram through E-mail (Soft copy only with subject RQP_EOI). In exceptional circumstances and at its discretion, CSIR-NIIST may extend the deadline for submission of proposals by issuing an amendment to be made available to all the RQPs registered with Department of Mining and Geology, in which case all the rights and obligations of CSIR-NIIST and the bidders previously subject to the deadline as extended.

A single pdf of all the scanned documents as per the formats prescribed in this EoI shall be sent to concerned scientist, Mr. Saurabh Sakhre on saurabh@niist.res.in on or before the last date of submission.

6. Validity of offer

The offer for EoI as per this document shall be valid for **ten days initially from the date of receipt of E-mail by RQPs** which may be extended further if required by CSIR-NIIST.

7. Terms of references

Following are the terms of reference for carrying out the proposed work. This terms of reference are framed as per the guidelines given in Enforcement and Monitoring Guidelines for Sand Mining (EMGSM-2020) issued by MoEF&CC.

- (i) Fulfilling all the relevant guidelines as given in section 4.3 of Enforcement and Monitoring Guidelines for Sand Mining (EMGSM-2020)
- (ii) The general structure of the mine plan shall include
 - General
 - Location and availability

- Infrastructure and communication
- Geology and exploration
- Estimation and calculation of geological resources
- Mineable reserves and Life of the mine
- Mining methodology
- Year-wise production plan
- Progressive mine closure plan
- Site services
- Transportation of sand from mine to destination
- Environmental Management Plan
- Plates depicting the geological, production & development and mine closure plan, conceptual plan and section

8. Time schedule

The time schedule shall be worked mutually for the potential sand mining sites based on the extent of site and location. The RQPs may provide the shortest period for completing the work once selected, based on the list of potential sand mining sites.

9. Inputs to be provided by CSIR-NIIST

- (i) District Survey Report for all the districts.
- (ii) Shape files of potential sand mining sites along with boundary coordinates.
- (iii) Sand reserves at each potential sand mining sites.
- (iv) Survey numbers / survey sketch of potential sand mining sites.

10. Deliverables

Soft and hard copies (2) of final approved mine plan covering terms of reference as given in section 4 of Enforcement and Monitoring Guidelines for Sand Mining (EMGSM-2020) issued by MoEF&CC.

The bidders are expected to examine all the instructions, forms, terms and other details in the EoI document carefully. Failure to furnish complete information as mentioned in the EoI document or submission of a proposal not substantially responsive to the EoI documents in every respect will be at the bidder's risk and may result in rejection of the proposal.

12. Qualification criteria

The following terms and conditions shall be applicable to the bidders:

- i. If an RQP is freelance consultant not registered with any firm, EoI will be solicited directly from the RQP. All the credentials and financial documents to be produced are to be based on the particular individual in his/her name.
- ii. If an RQP is employed at a registered firm, EoI will be solicited through the firm and there should be a certificate of endorsement of the RQP by the head of the firm.
- iii. If there are multiple RQPs employed at a single firm, the firm can endorse their RQPs as applicants in a single application/EoI, including credentials of all individual RQPs and financial documents of the firm.
- iv. In the event that multiple RQPs of a single firm are shortlisted in the selection process and enter a financial bidding phase, only a single financial bid by their firm will be entertained by the selection committee. Strictly only one financial bid from one firm will be considered in the selection process.
- v. As part of the selection procedure, the committee may invite the shortlisted applicants (both freelance consultants and employed at firms) for an in-person meeting to discuss matters related to their experience and other submitted credentials to make decisions on selection or rejection of candidates.
- vi. In the event that a work order is awarded to a firm, it will be binding to the firm that the particular RQP(s) selected by the selection committee will be engaged in executing the work and in no case a substitution will be made by the firm.
- vii. In the event that a selected RQP decides to leave his/her firm, the same shall be intimated by the firm to the institute. The ensuing financial matters will be settled as per the terms and conditions provided in the formal agreement. The need to engage a new RQP and the new candidate will be decided by the selection committee of the institute.
- viii. Receipt of separate applications/EoIs from different RQPs employed at a single firm/organization will lead to invalidation of all such EoIs.

The following will be the minimum pre-qualification criteria. Each eligible RQP should possess all the following pre-qualification criteria (**Table 1**). Responses not meeting the essential pre-qualification criteria will be rejected and will not be evaluated.

13. Evaluation criteria and method of evaluation

The following criteria shall be adopted for evaluating the EoIs

- a) Screening of EoIs shall be carried out as per the pre-qualification criteria mentioned in this document and based on verification of testimonials submitted.
- b) EoI will be evaluated for short listing/ award of work inter alia based on their past experience of handling/completing similar type of projects. The screening/selection

- committee may devise any additional evaluation criteria based on the applications received and overall performance of the RQPs/ bidders.
- c) CSIR-NIIST will take up references and reserves the right to pay due heed to the RQPs/bidder's performance elsewhere.

14. Response

The short-listed RQPs will be called for presentation/discussion and shall be issued tender document for submitting the financial proposal.

15. Conflict of interest

Where there is any indication that a conflict of interest exists or may arise, it shall be the responsibility of the RQP to inform CSIR-NIIST, detailing the conflict in writing as an attachment to this EoI.

CSIR-NIIST will be the final arbiter in cases of potential conflicts of interest. Failure to notify CSIR-NIIST of any potential conflict of interest will invalidate any verbal or written agreement

A conflict of interest is where a person who is involved in the procurement has or may be perceived to have a personal interest in ensuring that a particular RQP is successful. Actual and potential conflict of interest must be declared by a person involved during bid process.

This is to be noted that as the work demands survey on the field, any local factors like people's attitude in a survey area, sensitive areas, handling local agitation shall be the responsibility of the RQP/ bidder.

16. Conditions under which EoI is issued

The invitation for EoI is not an offer and is issued with no commitment. CSIR-NIIST reserves the right to withdraw EoI and or vary any part thereof at any stage. CSIR-NIIST further reserves the right to disqualify any RQP/ bidder, should it be so necessary at any stage.
